This refers to the Memorandum **DRRMS-08-15-2025-01** in response to the recommendation of this office on the request of the Disaster Risk Reduction and Management Service (DRRMS) for additional funds intended to support the response interventions such as clean-up and clearing operations and minor repairs of disaster-affected schools amounting to **Four Hundred Million Pesos Only (Php 400,000,000.00)**.

Following a thorough review and evaluation of the response and justifications provided, it is noted that despite efforts to maximize available funds, the remaining balances under the FY2024 Continuing and FY2025 Current Funds of DPRP have already been programmed, committed, and are in the process of implementation. Thus, it cannot be repurposed without compromising ongoing and priority interventions. It has been determined that an incurrence of deficiency for response interventions allocation is anticipated.

In this regard, this Office respectfully recommends the approval of additional funds for response interventions in the amount **Two Hundred Forty-Four Million Four Hundred Seventy Thousand Five Hundred Pesos Only (Php 244,470,500.00)**. The list was vetted and confirmed by the DRRMS Coordinators. Should this request be approved, this office will facilitate the downloading of funds, to **be charged against the FY 2024 Continuing Appropriation, General Management and Support – Central Office, MOOE**.

This refers to the recommendation from the Office of the Undersecretary for Finance (OUF) to maximize the use of available funds under the Disaster Preparedness and Response Program (DPRP), including the FY 2024 Continuing Funds and the FY 2025 DPRP Current Funds. This recommendation is in relation to the request for an additional funds of Four Hundred Million Pesos (P400,000,000.00) for the provision of clean-up and clearing operations and minor repairs of disaster-affected schools.

The Disaster Risk Reduction and Management Sector (DRRMS) respectfully emphasizes that the said funds have already been allocated and programmed for various programs, projects, and activities (PPAs) for the year, as detailed below:

FY 2025 DPRP Current Funds

The balance under FY 2025 DPRP Current Funds has already been programmed and committed to specific programs, projects, and activities (PPAs), as follows:

The above listed PPAs, particularly the funds for the upgraded TLS, are exclusively committed for delivery and therefore cannot be diverted for other purposes. The DRRMS has already cancelled other PPAs and pooled P27,059,850.00, which were reallocated to further augment response efforts. Accordingly, the FY 2025 DPRP funds are fully allocated to planned PPAs and ongoing interventions, leaving no available funding that may be used for augmentation purposes.

FY 2024 DPRP Continuing Funds

The unobligated allotment amounting to P712,126,734.48 under FY 2024 DPRP Continuing Funds has already been directly released to field offices. These consist of funds earlier downloaded for response interventions as well as remaining balances from prior disaster preparedness-PPAs. Most are already in various stages of implementation and utilization. Moreover, because these funds were direct releases, these funds cannot be withdrawn from the recipient regions.

To further ensure and expedite their effective use, this Office has prepared a memorandum, currently under review and for approval, which will:

- Direct field offices with remaining unobligated balances to prioritize these for response interventions; and
- Require the realignment of disaster preparedness-related PPAs under the FY 2024 Continuing Funds in favor of immediate response requirements, as needed.

With this, the proposed augmentation fund is deemed indispensable to the Department's disaster response operations. While measures have been set to maximize available funds from both FY 2024 and FY 2025 DPRP allocations, these resources have already been programmed, committed, and in the process of implementation, and thus cannot be repurposed without compromising ongoing and priority interventions.

To date, the DRRMS has consolidated pending requests for response interventions from affected schools totaling P317,843,000.00, which remain on hold due to lack of available funds.

The augmentation is therefore critical to ensure that the Department has sufficient and flexible resources to immediately respond to the needs of disaster-affected schools, while also safeguarding the implementation and delivery of its priority programs. More importantly, this augmentation will enable DRRMS to proactively and adequately prepare for anticipated hazards in the latter part of the year, thereby upholding the safety of learners and personnel and ensuring the continuity of education services.

In view of the above, the DRRMS hopes the approval of this request, to guarantee that the Department can sustain timely and effective response interventions for disaster-affected schools without disrupting its programmed and ongoing priorities.

DATE : July 28, 2025

In light of the increasing volume of requests from field offices following the recent series of hazards, the Office of the Undersecretary for Operations (OUOPS) respectfully endorses the request for additional funding support amounting to **Three Hundred Sixty to Four Hundred Million Pesos (P360,000,000-P400,000,000)** to enable the provision of Clean-Up, Clearing Operations (CUCO) and Minor Repair (MR) interventions in the affected regions, divisions, and schools.

Under the Fiscal Year (FY) 2025 Disaster Preparedness and Response Program (DPRP), the total standby funds allocated for response interventions at the Central Office amounted to Two Hundred Million Three Hundred Fifty-One Thousand One Hundred Seven Pesos (P200,351,107.00). In addition to this, a total of Twenty-Seven Million Fifty-Nine Thousand Eight Hundred Fifty Pesos (P27,059,850.00) have been pooled from the cancelled programs, projects, and activities (PPAs) of the Disaster Risk Reduction and Management Service (DRRMS) and reallocated to further augment response efforts, bringing the total available response fund to Two Hundred Twenty-Seven Million Four Hundred Ten Thousand Nine Hundred Fifty-Seven Pesos (P227,410,957.00).

Of this amount, Sixty-Six Million Six Hundred Fifty-Nine Thousand Five Hundred Pesos (P66,659,500.00) has already been processed for downloading to the affected field offices during the first semester of the year.

Moreover, in response to the recent impacts of Tropical Cyclones (TCs) Crising, Dante, Emong, and the Southwest Monsoon, the DRRMS consolidated and promptly acted on requests received from the field, amounting to One Hundred Thirty-Seven Million Six Hundred Eighty-Four Thousand Pesos (P137,684,000.00). These interventions were critical in facilitating the immediate resumption of classes and addressing urgent on-the-ground needs.

As of this writing, the remaining balance for response stands at Twenty-Three Million Sixty-Seven Thousand Four Hundred Fifty-Seven Pesos (P23,067,457.00). Given historical data showing heightened vulnerability to major hazards in the latter half of the year – including strong typhoons and other natural hazards, the DRRMS intends to hold this balance in reserve, leaving minimal buffer for further requests to ensure preparedness for potential large-scale events. Consequently, the DRRMS will temporarily suspend processing of requests from the field until additional resources are made available.

With the foregoing, this Office respectfully seeks the support of the Office of the Secretary (OSEC) and the Office of the Undersecretary for Finance (OUF) in allocating additional response funds to sustain the provision of CUCO and MR interventions. This support is essential to address the immediate needs of affected regions, divisions, and schools and uphold the Department's commitment to ensuring the safety, resilience, and uninterrupted learning of our learners and personnel.

The continued support and timely approval of this request will significantly enhance the collective capacity to respond effectively and safeguard the welfare of learners and personnel across the country.

I. EXECUTIVE SUMMARY

In response to the increasing number of hazard-related incidents affecting schools and field offices, the Disaster Risk Reduction and Management Service (DRRMS), seeks additional funding support amounting to **Three Hundred Sixty to Four Hundred Million Pesos (P360,000,000-P400,000,000)** to continue implementing Clean-Up, Clearing Operations (CUCO), and Minor Repair (MR) interventions. While P227.41 million in total CUCO and MR funds have been made available under FY 2025, a significant portion has already been processed for downloading, leaving only P23.06 million in reserve. With historically higher risks of major hazards during the second half of the year, there is an urgent need to replenish response funds to sustain ongoing and future interventions. This staff work formally seeks endorsement and approval of additional funds from the Office of the Secretary (OSEC) and the Office of the Undersecretary for Finance (OUF).

II. BACKGROUND INFORMATION

Under the Fiscal Year (FY) 2025 Disaster Preparedness and Response Program (DPRP), the Central Office initially allocated P200,351,107.00 in standby funds for response interventions. In addition, P27,059,850.00 was pooled from cancelled programs, projects, and activities (PPAs) of the DRRMS and reallocated

specifically to support response efforts, resulting in a total available response fund of P227,410,957.00.

As of the first semester of FY 2025, P66,659,500.00 has been processed and downloaded to field offices for immediate response interventions. Moreover, in response to recent hazards - including Tropical Cyclones Crising, Dante, Emong, and the Southwest Monsoon, the DRRMS acted on field office requests amounting to P137,684,000.00. These interventions played a crucial role in enabling the immediate resumption of classes and addressing critical needs on the ground.

Currently, the remaining balance of P23,067,457.00 is being reserved as a contingency for impending disasters, especially during the historically active second half of the year. In light of this, DRRMS has temporarily suspended the processing of further CUCO and MR requests until additional resources are secured.

III. OBJECTIVE

To secure additional response funds that will sustain and expand the provision of CUCO and MR interventions to regions, divisions, and schools affected by recent and forthcoming hazards, thereby ensuring the safety, operational continuity, and learning resilience of DepEd schools, personnel and learners.

IV. REQUESTED ACTIONS

- Endorsement by the OUOPS for the approval of the Office of the Secretary (OSEC) of the request for additional funding support for CUCO and MR response interventions amounting to Three Hundred Sixty to Four Hundred Million Pesos (P360,000,000-P400,000,000);
- Facilitation by the Office of the Undersecretary for Finance (OUF) of the identification and allocation of supplemental funds to augment the remaining balance of the FY 2025 DPRP response fund; and
- Immediate release of additional funds upon approval to allow the DRRMS to resume processing and responding to requests from field offices.

This refers to the request for an additional budget allocation amounting to **Four Hundred Million Pesos (P400,000,000.00)** for the Disaster Risk Reduction and Management Service (DRRMS) to support Clean-Up and Clearing Operations (CUCO) and Minor Repair (MR) interventions in affected regions, divisions, and schools.

Based on the Statement of Appropriation, Allotments, Obligations, Disbursements, and Balances (SAAODB) as of June 30, 2025, it was noted that the Disaster Preparedness and Response Program (DPRP) funds have **unobligated allotments** amounting to **P712,126,734.48** under the FY 2024 Continuing Appropriation and **P632,687,639.09** under the FY 2025 Current Appropriation.

In view of the foregoing, this Office recommends to **maximize** first the use of available funds, particularly the **Continuing Appropriation**, which shall be valid for obligation and disbursement only until **December 31, 2025** based on the National Budget Circular (NBC) No. 595¹.
