




The customized functions and duties of the Human Resource Merit Promotion and Selection Board are as follows:

Chairperson:

- Ensures that the selection of employees for appointment in the DepEd shall be anchored on the principles of merit, competence, fitness, and equality.
- b. Supervises in the evaluation and validation of profile, skills and competencies and potential and psycho-social attributes necessary for the successful performance of the duties required of the positions applied for by applicants.
- c. Presides the deliberation en banc of qualifications of those listed in the selection lineup and leads in making recommendations for appointment.
- d. Counterchecks the result of the ranking.

Members:

- validates and/or assess the profile, skills and competencies and potential and psycho-social attributes necessary for the successful performance of the duties required of the positions applied for by applicants.
- b. Evaluates and validates outstanding relevant work accomplishments, relevant experience, educational attainment and training appropriate.
- c. Conducts further assessment such as written examinations, skills test and interview of the qualified applicants.

HRMO:

- Conducts preliminary evaluation of the qualifications of the applicants vis-à-vis the approved Qualification Standards (QS) of the published positions to come up with the Selection Line-Up of Applicants.
- b. Provides the qualification standard for a position which shall include education, training, experience and eligibility required in the performance of the job.
- Publishes vacant positions in accordance with RA 7041 (Publication Law) which includes publication in the CSC Bulletin of Vacant Positions.

Secretariat:


- a. Prepares minutes of deliberation and meetings.
- b. Keeps records of the deliberations and other files related to the activities of the HRMPSB.

It is expected that the committee shall perform the functions and responsibilities strictly in accordance with the existing merit and promotion guidelines and shall uphold fair and just conduct of hiring of candidates for the welfare for our system.
