- Pursuant to the invitation from the Local Government of Dapitan City, through the City Social Welfare and Development Office, in partnership with the Local Council for the Protection of Children, the Schools Division of Dapitan City hereby encourages its participation in the 32nd National Children's Month Celebration of Dapitan City on November 15, 2024 at 8:30 a.m. at Dapitan City Cultural and Sports Center, Dapitan City.
- 2. The LGU invited a total of 300 elementary and secondary learners from select schools of the DepEd Dapitan City. This includes contestants of two (2) competitions, namely: Folkdance (for Elementary Level) and Hiphop Dance (for Secondary Level). There shall be one (1) contestant/group per district. The mechanics of these contests can be seen in the enclosure of this memorandum. The Song Solo Competition is only for the Day Care Learners.
- Schools shall ensure that there shall be no disruption of classes during the practice and attendance of the participants on the actual day of the activity. Hence, classes of coach or chaperone teachers shall be handled by any available teachers.
- Expenses relative to the participation of schools in the said activity shall be charged against
  the school local funds, subject to the usual accounting and auditing rules.

#### SONG SOLO COMPETITION MECHANICS: ( Day Care Learners)

- 1. The contestant of the Song Solo Competition should be 0-5 years old and a bonafide resident of the LGU (Dapitan) he/she is representing.
- 2. The duration of the song should be a minimum of 2 minutes and maximum of 3 minutes.
- 3. The competition music must not contain inappropriate, lewd, or offensive language.
- 4. Strictly no lewd, obscene and sexy dresses and gestures.

# FOLK DANCE COMPETITION MECHANICS: ( Elementary / By Dufrict)

- 1. All dancers have a minimum of (4) and maximum of (6) members.
- 2. All members of the group should be 6 years old to 10 years old and a bonifide resident of the LGU (Dapitan) they are representing.
- 3. The duration of the dance should be a minimum of 3 minutes and a maximum of 5 minutes.
- 4. Materials/props that will cause the stage to become slippery or dangerous are strictly prohibited.

# HIP HOP DANCE COMPETITION MECHANICS: (Secondary Schools)

- 1. All crews have a manimum of (6) and maximum of (10) members.
- 2. All members of the crew should be 11 years old to 17 years old and a bonafide resident of the LGU (Dapitan) they represent.
- 3. The competition music must not contain inappropriate, lewd, or offensive language.
- 4. The duration of the dance should be a minimum of 3 minutes and a maximum of 5 minutes.
- 5. Any kind of hiphop dance is allowed (locking, popping, krump, house, stepping, breakdance, wacking, tutting, vogueing party dances, hip-hop choreography) or any kind of dance with hiphop as their focal thought of choreography, provided that the choreographers of the group have the proper knowledge or background to execute it properly.
- 6. No vulgarity, obscenity, and explicit contents are allowed.
- 7. Attire may include accessories such as hats, scarves, caps, gloves, jewelry, etc. Removing pieces of clothing during the performance is permitted provided it is not offensive or out of character.
- 8. All costume malfunction resulting team members being exposed are grounds for deductions. Please make sure to have dress rehearsals prior to completion to work out any costume problems.
