# CONDUCT OF INTENSIVE MONITORING OF BAWAT BATA MAKABABASA PROGRAM (BBMP) IMPLEMENTATION.

- 1. The Department of Education through DepEd Order No. 10, s. 2025, titled Guidelines on the Implementation of the 2025 Department of Education Summer program, and the DepEd order No. 34, s. 2025 titled Supplemental Guidelines on the Implementation of Bawat Bata Makababasa Program (BBMP), underscores the urgent need to intensify reading intervention to address learning gaps among early grade learners and institutionalizing reading proficiency programs to support learning recovery. BBMP is introduced as an initiative designed to ensure that all struggling readers attain grade-level reading proficiency.
- 2. In support of our goal to improve literacy levels and ensure the effectiveness of BBMP, all Education Program Supervisors, Public Schools District Supervisor, Principal Incharge of the District and School Head are hereby directed to conduct intensive and consistent monitoring of the program implementation across all participating classes.
- 3. This directive includes the following responsibilities:
  - A. Conduct classroom observations on tutorial sessions to assess the fidelity of program implementation.
  - B. Monitor learners progress and ensure that tutorial sessions are properly documented.
  - C. Evaluate the use of instructional materials and ensure alignment with the prescribed strategies.
  - D. Identify areas of concern and provide timely feedback, coaching and technical assistance.
- 4. Supervisors and school school heads shall submit monitoring reports highlighting findings, best practices and recommendations for improvement to the CID Chief.
- 5. Your active participation is crucial in ensuring that our learners receive the support they need to enhance their reading skills.
